- AmicusHorizon employees receive a performance-related payment of up to £500. Chief executive Steve Walker's payment is reflected in his total salary figure.
- Mick Kent, chief executive of Bromford Group, has a company car. This is not reflected in his total salary figure.
- In May, the board of Derwent Living offered chief executive Peter McCormack a bonus for 2010 but he deferred taking it because of the current financial climate. This will be reconsidered later this year.
- Paul Crawford joined Devon & Cornwall Housing in November 2009, the figures shown for 2009/10 are the equivalent of a full year's salary.
- Chan Kataria, chief executive of East Midlands Housing Association, receives a benefit in kind for a company vehicle rather than a car allowance. Nevertheless, this is included in his total salary figure.
- June Barnes, chief executive of East Thames Group, took a sabbatical in 2009; however the total salary figure for 2009/10 reflects the equivalent of a full year's salary. A 2 per cent unconsolidated payment was made to all East Thames Group staff in 2010/11 for the 2009/10 period. This is reflected in Ms Barnes's total salary for 2010/11 - however, Ms Barnes did not accept a bonus.
- A breakdown of Family Mosaic chief executive Brendan Sarsfield's total salary figure was not available. This means details of his bonus have not been considered for the table Top 10 bonuses.
- First Ark Group was listed previously as Knowsley Housing Trust.
- Puspha Raguvaran, chief executive of Housing 21, was chief exec for nine months in 2009/2010. Total salary details are equivalent to a full year.
- David Eastgate was chief executive of Hyde Group until 31 December 2010. Steve White became chief executive on 1 January 2011.
- The turnover figure for Irwell Valley Housing Association incorporates its subsidiaries. A breakdown of chief executive Tom Manion's total salary figure was not available. This means details of his bonus have not been considered for the table Top 10 bonuses.
- Matt Cooney took over as chief executive of LHA-ASRA in June 2010. However, the figures shown for 2010/2011 reflect the equivalent for a full year's salary. The previous chief executive was Atul Patel.
- Metropolitan Housing Partnership would like to point out that it is also a substantial provider of care and support services
- Andrew Orrey, chief executive of North Lincolnshire Homes, joined in May 2010. The previous chief executive was Jane Duncan.
- Mick Sweeney, chief executive of One Housing Group's bonus details were not given and are therefore not included in total salary figure. Mr Sweeney has a lease car - the cost of this is not reflected in the total salary figure.
- A deferred salary payment accounts for 3 per cent of the 4 per cent increase in Clive Turner, chief executive of Plymouth Community Homes's total salary between 2009/10 and 2010/11.
- Bonus and car allowance information was not provided for Lindsay Todd, chief executive of Radian Group, so is not reflected in his total salary figure.
- The turnover figure for Richmond Housing Partnership incorporate's the housing association's subsidiary Co-op Homes.
- Victor da Cunha took over as chief executive of Somer Housing Group in April 2011. The figures for 2010/2011 relate to the salary payable to the post of permanent chief executive. The amount paid to the interim chief executive employed during that period was set in line with this figure.
- Vela Group brings together Housing Hartlepool, which was listed in last year's survey, and Tristar Homes.
- Kevin Dodd, chief executive of Wakefield & District Housing, did not take full salary entitlement for 2010/11. Directors of the housing association are on the same terms and conditions as all other employees, and do not receive bonuses.
- David Pickering, chief executive of Waterloo Housing Group, has a company car. This is not reflected in his total salary figure.
- Pat Brandum took over as chief executive of WM Housing Group in July 2010. The total salary figure shown for 2010/11 is the equivalent of a full year's salary. However Farrand was chief executive of WM Housing Group in 2009/10. He was unavailable to participate in last year's survey.
- Wrekin Housing Trust is unable to participate in this year's survey because the housing association's accounts are published after Inside Housing goes to press.
- Mike Kay, former chief executive of Yarlington Housing Group, left the housing association in January 2011. Gary Orr took over as chief executive in July 2011.
